

Talk about whats happening now. We needed to carry bills that BSC promised. When we were asked questions we tried to change things. BSC has negative 9k in bank. With rsl coming on board – terry explained if rsl come on board what will happen that ultimately all debts wiped.model has failed and that simple. Bfc made

10k trading profit in sept but without paying bsc costs. As good as it is if the rsl come in it does not fix our situation one bit. Other member clubs on board. Sponsors have come on board to provide products to help assisting the running of the facility. Petering on board to get players to do 3 shifts per year to help assist bar.

Clarke explained the structure and process of what will happen if and when rsl come in.

President's Report 2020

To say 2020 has been a unique and challenging year is an understatement. I firstly want to acknowledge the impact of Covid globally, on peoples' health, lives and businesses. It has been a tough time for many. From a football club perspective, it stopped the very game we love to play or watch. However, it didn't stop us. It cannot stop us. While not one game of footy was played, a lot of activity went on behind the scenes, positioning our club for a successful 2021 and beyond.

I'm a very proud Shark. I'm inspired by the kids and young adults that pull on the jumper, the volunteers that work so tirelessly, the past players who love and support their club, the life members who continue to give, and our loyal supporters and community who love the blue and gold. It's all of you that make our club great. While we didn't get a chance to watch the footy this year, I'm very confident that season 2021 will be a beauty.

We had our challenges this year, but we performed well financially, we retained our players, coaches and committee for 2021, and we are recruiting new talent. We also have managed to secure our upstairs clubrooms for the first time since the building opened. The main area will be ours to operate in footy season. That's a significant result for us as a club, and has taken many hours of hard work to get there. The Shark spirit inside our clubrooms will be back bigger and better than ever in 2021.

There are a number of things to reflect on positively this year despite no games being played:

- Player retention is the best it has been for a number of years, with all our senior and junior players excited and eager to get into 2021. Pre season training for the seniors begins on 24 November;
- With the help of some of our key sponsors as well as some strong support from our
 coaching group and junior section, the club returned an operating profit of
 approximately \$43k in 2020. The senior section also was able to achieve a positive net
 cash result, including paying some debts that were carried over from season 2019. This
 was no mean feat in a season with no games, limited sponsor revenue and no bar or
 food revenue.

- Amazing financial support from the following sponsors: Askin Group, Beaumaris Community Bank, Bruce Edmunds & Associates, Bayside Medical Centre and Priceline Pharmacy Southland. Their financial contributions (totaling \$40k) were extremely important to the financial success of 2020 and I thank them from the bottom of my heart. Steve Clarke at Askin Group wrote the club a big cheque when we needed it most. Stephen Edmunds from Bruce Edmunds and Associates showed tremendous loyalty by continuing to commit his firm's major sponsorship despite the business climate deteriorating during Covid. The Beaumaris Community Bank continued to show their generous community support with their large sponsorship contribution. The three amounts from these major sponsors were critical to our 2020 financial performance. Bayside Medical Centre and Priceline Pharmacy Southland also made significant contributions, with the latter paying for a new set of jumpers for our women's team.
- Some of our other club sponsors helped sell BFC masks. Every dollar counts. Special thanks to Casa Dolce, IGA, Beaumaris Community Bank and Saska.
- All our senior coaching group were committed to 2020 right through to the final decision to cancel the season. They are all returning for 2021. We have also added Josh Bourke, Jonno Nash and Justin Wilson to our 2021 team.
- Former Under 19's Premiership coach, Josh Bourke, has recently accepted a new role at the Sharks. Josh is taking on a dual role, being Senior Assistant Coach (with forward line responsibility) as well as the head of our new Sharks Senior Development Academy.
- Jonno Nash will come on board with the Sharks in an off field role in 2021, working with Lachie Batt coaching our midfield.
- Alex Byrne has accepted the role of Football Coordinator and Team Manager for the Women's program.

The cricket club will do the same in cricket season. The tennis club will have a lease for the Banksia Room/Member's Bar area. We are delighted that all three clubs will get the opportunity to have an area they can call their own. Of course all members from each club are welcome to use any of the upstairs area. We also will welcome the RSL to the facility at any time during operating hours. RSL Wednesday nights are also planned to continue.


MERRY XMAS AND BRING ON 2021

Treasurers Report - Year Ended 30 September 2020

The financial statements for the 30 September 2020 financial year, have been prepared on an aggregated basis combining the operating results of both the senior and junior club operations of the Beaumaris Football Club (BFC).

As the Club's turnover generally exceeds the threshold of a 'tier 2 entity' under the Corporations Act Victoria the Club is required to have its financial statements reviewed by an independent auditor.

Operating Result Summary

The Covid-19 pandemic and resultant cancellation of the 2020 football season has had a flow on impact to the BFC's revenue and expenses for the 30 September 2020 financial year. The operating profit of \$18,621 for 2020 represents a more than \$43,000 increase on the prior year loss of \$24,947 and is an excellent outcome reflecting the continued support of key sponsors, club members, coaching / support staff and all the many people who have continued to work on the myriad of day to day, as well as ad-hoc activities that are required to not only maintain the club, but enable it to prosper and grow. An analysis of the main income and expense items for the year and commentary thereon is set out below:

Notes to the Financial Statements - Year Ended 30 September 2020

1 Summary of accounting policies

Basis of preparation

The financial statements have been prepared on an accruals basis and are based on historical cost. The financial statements are special purpose financial statements prepared in order to satisfy the requirements of the financial reporting requirements under the Associations Incorporation Act Victoria. In the opinion of the management committee, the Beaumaris Football Club (BFC) is not a reporting entity because there are no users dependent on general purpose financial statements.

Accounting policies

The accounting policies adopted by the Club are stated in order to assist in a general understanding of the financial statements. These policies have been consistently applied except as otherwise indicated.

Change in Operations and Points to oNote

Covid-19

The on-set of Covid-19 has resulted in no football being able to be played during the 2020 season. From a pure football perspective this was disappointing given the hard work that had gone through in pre-season training and the strong numbers, commitment and enthusiasm from players, coaches, support staff that had been built leading into the 2020 season. This has had a large impact on both revenue and expenses for the 2020 year, for example the offer of refunds of subscriptions paid due to the Government prohibiting play.

Clubroom Operations

Further to recent Bayside council approval, it is expected that the Beaumaris Football Club (BFC) and Beaumaris Cricket Club (BCC) will shortly sign a new lease for the upstairs facility of our clubrooms. This will involve that BFC operating the main upstairs area (including bar and kitchen) in footy season and the BCC will do the same in cricket season.

Other Income

The Club applied for and was successful in receiving a \$1,000 Covid-19 grant (included in other income).

Merchandise Costs

Included within the merchandise costs are costs associated with purchasing trainer's tops, polos and jackets provided to coaches/team managers and bibs for officials etc. Where possible these costs are subsidised through sponsorship, with associated income recognised within Corporate Sponsorship income.

2 Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Subscription income is shown net of direct expenses comprising (1) medical and insurance expenses (\$nil: 2019 \$21,076), (2) player equipment and bag costs (\$7,300: 2019 \$10,306) and (3) coaching co-ordinator and coaching costs (\$12,300: 2019 \$31,000). This income received by the Junior section of the Club is treated as a sub-entity of the Club for GST purposes.

The Bendigo Bank in Beaumaris were truly wonderful and professional in their approach and provided a low-cost alternative to us, which enabled the club to achieve a maximum refund to our members., and the MCC graciously offered not to charge us rent for the facilities at the secondary college, Thanks to Mark Anderson and Scott West from the MCC for their efforts.

It would be remiss of me not to acknowledge and thank on behalf of the club, those families who offered to donate their refunds back to the club, and the many emails and messages of thanks and support we received during this time.
